Doug Weisenauer moved to purchase 391 Atwood St Galion for \$2000 in order to prevent this property to be sold and continue being an eyesore. Jeff Reser seconded the motion and stressed that the Land bank should not be in the practice of purchasing properties. Gary Cole stated that at this point we could use grant funding to make the purchase and we need additional properties in order to fulfill the use of the grant. Motion passed.

Doug moved to accept 418 South Union St Galion contingent on title search. Jeff Reser seconded the motion, motion carried.

Doug Weisenauer moved to purchase 217/219 E Walnut Galion for \$1,600 + tax lien and contingent on title search. Jeff Reser seconded the motion, motion carried.

Doug Weisenauer moved to accept 321 E Warren St, Bucyrus contingent on title search. Jeff Reser seconded the motion, motion carried.

Doug moved to accept 891 Harding Way East, Galion contingent on title search. Jeff Reser seconded the motion, motion carried.

Doug Weisenauer moved to accept vacant land at 413 Rail Road St, Galion and donate the property to adjoining landowner. Jeff Reser seconded the motion, motion carried.

Gary discussed that there are other properties being considered for addition to the list for the upcoming meetings.
